- **3.** The Tenant shall be liable for any damaged or injury whatsoever caused by the pet/s on the property, whether they are the Tenant's pets or their guests pets and regardless of their approval status.
- **4.** The Tenant accepts full responsibility and indemnifies the Lessor for any claims by, or injuries to, third parties or their property caused by, or as a result of actions by their pet/s, and regardless of the approval status.
- **5.** The Tenant agrees to arrange for flea fumigation and steam clean of the carpets at the end of the tenancy to be carried out by a company complying with Australian Standards.
- **6.** If the pet is a dog, the Tenant agrees to restrain or remove the dog from the premises for the duration of inspections arranged by the Agent with the required notice given.
- **7.** By signing below you are only asking for approval of the above-mentioned pet/s to be accepted at the property for which you are applying.
- **8.** If approved, this application will serve as your agreement to the above terms and conditions for the duration of the tenancy.
